#### Has enough effort been made to explain to all groups the value and purpose of a GSR?

Some groups choose not to participate and many people don't know what a GSR dies. We need to do a better job to inform more groups about the benefit of service. We need to promote the use of envelopes.

#### Do all GSR's have adequate opportunity to serve on committees?

Yes, almost all our committees are currently vacant.

#### Are district officers picked with care and consideration?

Yes. We follow our service manual and use our 3<sup>rd</sup> legacy procedures to elect officers and have asked an Area officer to conduct our last district elections as an impartial observer.

#### Do our groups carry their fair share of supporting the Area and the **General Service Office?**

Yes and no. One group voted not to support GSO because they were deficit spending and this group plans to revisit their vote. We need to work harder at this.

#### How well are our groups informed about what is happening in AA worldwide?

Not very well, we are doing this and can do a better job of this. We need to promote the Grapevine and PO Box 459, which is informative about the activity of GSO and alcoholics.

#### Are our District Meetings informative and enthusiastic?

Yes. Sometimes we need to focus on topics and not go off subject so much.

#### **OUT OF THE HOLE**

IN JULY, I was sentenced to eight years for robbing a drug store while drunk. Certainly this harsh sentence would get me sober. But it didn't. My self-pity was deep. I spent the first two in jail drinking and using drugs. I became so loaded on a daily basis that it was apparent to everyone. I even tried to commit suicide twice in those last couple of weeks, and failed. The powers that be rolled me up from, that prison's prison the hole. There, I came to know the loneliness that the Big Book speaks of. I was completely empty on the inside. I had nothing left. I was miserable with the drink and without.

On July 24, 2004, I asked God to help me change. That was my only prayer. I had been in and out of AA for 25 years. I knew about the program, but I never completely surrendered to it, nor to God. That day is my sobriety date.

After a rough year of getting transferred around, I ended up at a decent yard and started going to meetings again. I stayed sober that next year out of desperation, and by the grace of God. I made my first-ever one year without a drink in that yard. Soon I was elected chairman of our meeting, a commitment I held for the next four years.

All this was great and amazing, but I was scared to death. I was going to go home in a few years, and I had no clue how to live or function on the outside sober. I had never done it. I started working the steps in desperation. The H&I AA members who brought meetings in to us assured me I could do this program no matter how many times I had failed.

Somewhere between my second and third year sober, I was walking back to my cell after a meeting and for the first time ever I felt good about my life and myself. I had true hope in that moment. It blew me away. This was a true spiritual experience. I started thanking God for everything - even the bad food and cold showers, but especially for the gift of sobriety.

Soon it came time for parole. I followed all the suggestions of my sponsor and the H&I panel members. I went to an AA meeting my first day out. I got a new sponsor, and I got into service. I have three H&I commitments now. And even though the economy is in terrible shape, I found work. And I've also since been let go. But nothing is worth drinking over today. By the grace of God and the fellowship of AA, I have hope today. One day at a time, I don't have to drink.

#### **BRIDGING THE GAP**

Bridging the Gap is a wonderful service that help alcoholic's locate AA meetings the day they leave a treatment program or correctional facility. The way each group is set up differs depending on the area, and they sometimes go by a different name. But it's usually made up of volunteer AA members who sign up to contact new members, meet them at the door of the facility or at an AA meeting, introduce them to other AA's, make sure they get phone numbers, and try to help them find a sponsor. In the following story you will hear how one shares their Bridging the Gap experience.

#### H & I Report

Santa Barbara North County Hospitals & Institutions Committee is dedicated to providing AA meetings and literature to those confined in hospitals, jails, prisons, and other facilities that request support from Alcoholics Anonymous. SBNC Hospitals & Institutions Committee serves the 52ne District and meets on the third Thursday of every month at the Freedom Group in Lompoc at 6:45 PM. Those who are interested in an indescribable experience, and want to greatly enhance their sobriety, then join the meeting and see if H&I is for you.

## Your 52<sup>nd</sup> District DCM Report DISTRICT INVENTORY

#### What is the basic purpose of the District Committee?

Our purpose is to be liaison between our groups and service structure, to exchange experience about our group success and failures. To take suggestions from other groups that have experienced the challenges we face and report them back to our group. Make a spiritual connection with alcoholics worldwide. Provide our delegate with information and concerns from our group so that he or she can be informed and ensure that our group be have a voice at all the levels of AA.

Help insure that our traditions are being followed. We pull our resource together to help carry the message of love, recovery and hope to alcoholics suffering outside the rooms and throughout the 52<sup>nd</sup> District.

## What additional activities can we engage in to carry the message?

We need to find Alcoholics who will serve as PI and CPC Chairs in order to help lead us in taking actions and hosting unity days in the district and with other districts.

## Considering the number of alcoholics in our district, are we reaching enough people?

We can never reach enough people. People are either ready or not, but we do what we can to carry the message to alcoholics. The best way, is how we act by living examples of the book. By a simple vote and show of hands 11 to 1 members of the group stated their groups are currently growing in size and one said they were not growing at this time

# What has the District done lately to bring the AA message to the attention of professionals who can be helpful in reaching those who are in need of AA?

Sponsor your doctor packets that we used last year to inform our doctors about how we abuse the medical system and how they spot an alcoholic and refer them to AA.

## Do we try to illustrate a good cross section of AA in our message carrying?

Based on the members present and participating in the inventory we responded with a unified, yes.

## <u>Do new GSR's stick with us, or does our turnover and missed meetings seem excessive?</u>

Based on the members present participating in the inventory, we responded with a unified stick. We have a strong core of GSR's and find that 2 or 3 will miss a meeting per month but never enough to prevent the district from holding a meeting or conduct its business. 75% of new GSR's have less than 5 years of sobriety, 10% have 5-10 years of sobriety and 15% have over 20 years of sobriety.

#### How effective are we in communicating with our groups?

We need to do a better job of communicating with our groups that do not have GSR's, especially in the Lompoc and Santa Ynez Valleys.

## Do all AA's know about district meetings and have the opportunity to attend?

Yes, all members and visitors have an opportunity to attend and participate. Many members will car pool to assist with better attendance. We believe some groups are aware and choose not to participate in service groups or don't have a willing representative.

#### **Trip Io China**

Carrillo Community Medical Center in Santa Barbara was my place of employment from 1949 to 1999. The landlord of the clinic was Dr. Luan who escaped from the Communist Chinese in 1949and completed his medical training in Chicago before moving to New Mexico for his practice and then on to Santa Barbara for his retirement. One day Dr. Luan walked into my office and said "I am going to adopt you as my son. "Really?", I said. Dr. Luan knew that I had lost my father to alcoholism when I was 18. It was a Chinese cultural practice that a man who was old enough to be another man's father and that father was diseased. The older man could "adopt" the fellow. I discovered it was like a sponsorship relationship. The next year Dr. Luan walked into my office and said, "I want to take you to my home town in China." I said, "OK." We were going over with an eye surgery team, but a tourist visa would not work for my visit. I needed a health issue to speak on while in China. The Chinese had expressed a desire to speak on HIV/AIDS, but I requested alcoholism. The Chinese accepted. They found a mental institution in Dalian near the North Korean border. I contacted WSO of AA and discovered that the Big Book had been translated into Mandarin six months before. I was supposed to speak to five doctors, so I bought five Mandarin big books at \$18.00 each. I spoke to 30. I wish I had bought more. On the flight to Tokyo, I realized that I was not sure what I was going to say to these doctors. When in doubt, use what works. So, I had Dr. Luan go through the Mandarin and find the portion of chapter 5, and 12 Traditions, which we read to the doctors. They were read by Dr. Lu who received his MD from University of Vienna, the same school and as Freud and Jung. The readings were received well by the medical staff, but all of the questions that followed were Al-Anon type questions. My response was to have two drunks in each locked room with the Big Book and leave them alone. For this moment, I just got blank stares. After going to the mental institution, Dr. Luan and I had dinner with the Communist Governor of Manchuria. During dinner the governor stated he thought AA in China would be a good idea and wondered if his drinking would cause me to drink. Since my visit to China, Dr. Luan has gone back with 14 alkies from San Francisco to participate in addiction caravan travelling the country and educating on tobacco, alcohol, and drugs. Dr. Luan has also taken medical students from Yale and alkies to China in the same group. It was very educational for both parties. AA has grown significantly since my visit to China. I encourage anyone who travels abroad to visit meetings. I have gone to meetings in Fortuna, Costa Rica and the Pacific group on the Pacific Coast of Costa Rica. Peter B., Los Alamos, CA.
